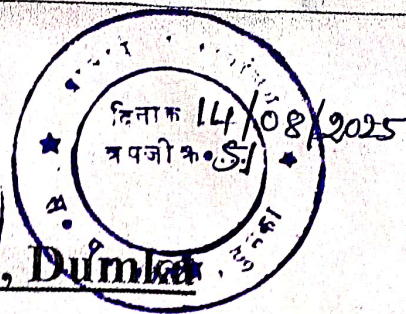

Advertisement for the Post of Temporary Assistant Professors in the B. Ed Department (Self-Financed Course)

Eligible and interested candidates are requested to appear at a walk-in interview for appointment as Assistant Professor on purely temporary basis in the B.Ed. Department of 05 constituent colleges of the university.

Eligibility:

As per the NCTE Regulation-2014 (as amended up to date) and statutes notified by the Department of Higher & Technical Education, Jharkhand, vide Letter No. 492 dated 24.02.2023 and amended vide Letter No. 2589 dated 28.12.2023. Details are available on the University website: www.skmu.ac.in.

Service Term & Conditions:

This appointment will be purely on temporary basis dependent upon continuation of the course or until the candidate reaches the age of 65 years, whichever comes earlier.

Process to Attend Walk-In Interview:

1. Eligible and interested candidates should fill the application form in the prescribed format available on the official website of the University www.skmu.ac.in.

2. Candidates have to bring duly filled-in application form along with the Demand Draft of ₹1,000 (for General/EWS/OBC candidates) or ₹500 (for ST/SC/PH candidates) drawn in favor of the Registrar, Sido Kanhu Murmu University, payable at Dumka (candidates from outside the State of Jharkhand will be treated as General irrespective of their category) and self-attested copies of all relevant documents.

- Self-attested copies of all educational certificates and marksheets (from matriculation onwards)
- NET/JET/Ph.D. Certificate
- Experience Certificate (if any)
- Caste certificate (if applicable)
- Residential certificate (if applicable)
- EWS certificate (if applicable)
- NOC (if employed)
- Undertaking by the applicant (format available on the University website)
- Relevant documents for conversion from grade to percentage prevalent in your University/ Institution for OGPA/CGPA of 10th /Matriculation, 12th /Intermediate, Graduation and Post-Graduation (If applicable) must be attached along with the mark sheets being submitted at the time of applying.
- Others (if any)

3. The Walk-In Interview will be conducted at Dighi Campus of S.K.M.U., Dumka at 10:00 am on 18.08.2025 (Monday)

4. Selection will be made as per the statutes notified by the Department of Higher & Technical Education, Jharkhand, via Letter No. 492 dated 24.02.2023 and amended via Letter No. 2589 dated 28.12.2023 and the NCTE Regulation-2014 (as amended up to date).

General instruction for applicants:

1. Reservation policy will be followed as per the Jharkhand State Government rules.

2. All educational qualifications must have been obtained from recognized Universities/Institution in India and/or abroad and if grades are awarded instead of marks, applicant should clearly indicate their equivalent percentage.
3. Once the application fee is submitted, it will not be refunded in any case. As applicants are advised to ensure their eligibility as per advertisement,
4. Candidates from the SEBC (OBC) categories must submit a valid certificate for the current year in prescribed Proforma of the Government of Jharkhand. The certificate must explicitly state that the candidate does not belong to the creamy layer. Otherwise, the candidates will not be allowed to attend the interview.
5. Candidates from the EWS categories must submit a valid certificate for the current year in prescribed Proforma of the Government of Jharkhand. Otherwise, the candidates will not be allowed to attend the interview.
6. Incomplete application in any respect is liable to be rejected.
7. The University reserves the right to reject any application or entire advertisement without assigning any reason thereof. The decision of the university will be final in this regard.
8. The University reserves the right not to fill any post(s), in case of non-availability of suitable candidates.
9. The University reserves the right to terminate the services of the appointed teacher without assigning any reason or due to non-satisfactory performance.
10. No TA/DA will be paid for the entire selection process.
11. The vacant posts advertised may be increased or decreased as per requirement.
12. In case of any doubt, the applicants are advised to go through the statutes notified by the Department of Higher & Technical Education, Jharkhand vide Letter No. 492 dated 24.02.2023 & amended vide letter no. 2589 dated 28.12.2023 and NCTE Regulation.
13. University reserves the right to change or modify the schedule if so becomes necessary.
14. Candidates must bring the original demand draft during the walk-in interview.
